



Our proposal is for 44 new homes:

Perham Way, London Colney STRATEGY AND OVERVIEW






The proposed new homes are a blend of traditional forms; contemporary design elements and a palette of materials have been taken from the surrounding area with buff & red bricks, grey windows and roof tiles.

The landscape design incorporates the retention of majority of existing trees and responds well to a very constrained site using an appropriate level of new planting.




Chalkdene want the community to benefit from the development and where possible will be:

St Albans City and District Council is starting a new Local Plan. The new Local Plan period will start from 2020 and end in 2038.

In starting a new Local Plan, the Council is required to undertake a number of processes. These include:

- Adopting a Local Development Scheme
- Consulting on a Statement of Community Involvement
- Consulting on the scope of the Sustainability Appraisal
- Inviting representations for a 'Call for Sites 2021'

Consultation will run from Monday 25 January 2021 until 5pm on Monday 8 March 2021.

The consultation is an opportunity to shape St Albans City and District Council's approach to involving residents and other stakeholders in the planning of the District. Suggestions are welcome on the community engagement techniques to encourage effective participation.

Call for Sites 2021

The 'Call for Sites' is an early opportunity for individuals, landowners and developers to suggest sites within the District for development over the next 15 to 20 years. The site suggestions received by us will be used to inform the preparation of the new Local Plan 2020-2038.

You are invited to put forward any new sites that you would like the Council to consider in its Housing and Economic Land Availability Assessment (HELAA). These should be capable of delivering 5 or more dwellings, or economic development on sites of 0.25 hectares or more (or 500 square metres of floor space or more). The Council will take account of the Strategic Housing Land Availability Assessment (SHLAA) submissions previously received since 2009 and therefore there is no need to resubmit these unless circumstances have changed. Sites from previous SHLAAs will form part of the Council's assessment. Proposed land uses can include:

- Gypsy & Travellers
- Mixed Use
- Employment
- · Renewable and low carbon energy and heat
- Biodiversity Improvement / Offsetting
- · Green Belt Compensatory Land

- Land for Tree Planting
- Other
