SUBJECT: CHRISTMAS LIGHTS

**INCREASE IN TESTING REGIME & ASSOCIATED COSTS** 

## 1. SUMMARY

1.1 The Council's Christmas lights contractor have advised the Clerk that the testing regime for Hertfordshire County Council equipment (lamp columns), has been updated which means an increase in costs.

#### 2. RECOMMENDATION

- 2.1 Members are asked to:
  - a) Note the change in testing regime for lamp columns
  - b) Consider if they want to reduce the number of columns to accommodate the increase in costs.

#### 3. BACKGROUND

- 3.1 Hertfordshire County Council and Ringway have altered their testing requirements in line with new Guidance Notes (GN22). This is a much more involved process and requires structural engineers to confirm the suitability of each column for each decoration.
- 3.2 This means that costs for these works have increased considerably and that a separate visit is required for the electrical inspections, so these costs have increased also. We are also being advised that they are looking for all columns to have separate isolators for street lighting and Christmas lighting circuits to be installed. Should they insist on this, costs will be in the region of £150.00 per column.
- 3.3 Currently the parish council has a contract with Lamps and Tubes to install the Christmas lights display for 3 years from 2019-24. An annual application is made to Hertfordshire Highways to erect Christmas lights on their equipment. This includes the relevant column structural tests and electrical connections. Failure to provide this information to Herts Highways will mean a licence is not issued and the parish council may be liable to pay costs if any damage was to occur to the columns.

## 4. FINANCE


- 4.1 There is a budget for Christmas Lights (4300/210) of £9,000.
- 4.2 The new structural testing will mean that the spend for the Christmas Lights in 2022 is £9999.00.
- 4.3 If additional isolators are required then the costs will be an additional £3,300 or £13,299.

SUBJECT: FIREWORK CONTRACT 2022-24

#### 1. SUMMARY

1.1 This report summarises the submissions for the Firework Contract for 2022-24.

#### 2. RECOMMENDATION

2.1 Members are asked to consider the quotations outlined in this report and appoint a firework contractor.

## 3. BACKGROUND

- 3.1 The Council's contract for supplying the annual firework display was extended in 2021 after the 2020 display was cancelled due to Covid. This contract will run from 2022-24 for three years.
- 3.2 Two responses were received which are detailed below. Tenderers were asked to provide proof of membership of the British Pyrotechnics Association, relevant health and safety adherence and sufficient levels of insurance cover.
- 3.3 They were also asked to consider the parish council's resolution to use more 'silent' fireworks.

## 4. FINANCE

4.1 There is a budget for the event. It was agreed at a previous committee meeting to apply a 10% increase in the budget for the firework display each year over the life of the contract.

Formed in 1995, expanded in 2005 following the purchase of two further companies. No further plans to expand other then increasing their business and taking on another member of staff to handle the additional work.

Micro 2 managerial 3 operational 15-20 sub contractors			Our stock is handpicked to build coloured sequences building in intensity as the display progresses. We make full use of the site width, firing material at angles and from multiple positions in order to add impact and a fuller display. We do not use any ground-based fountain effects as they are not easily seen by the audience standing further back. The display will be choreographed to a bespoke music track. We compile a new sound track each year with a variety of tracks and use them to make the show compilation. The tracks are edited down to around 90 seconds in duration so as to include a verse and chorus and not to repeat for the full length of a track. Our experience and feedback have shown over the years that a mix of popular and well-known music is most well received by our audiences. We may use the most recent track from a Bond film, TV drama as well as any current Disney movies etc. The more the audience recognise the music the more they react to it and remember it. Our displays are always choreographed to the tracks, and we produce highs and lows with the music and match the fireworks accordingly. This enables us to use a selection of quieter product that is requested more and more these days. We plan to make 50% of the display slightly quieter, by choosing less noise related products  In place of the suggested 'Good Night' Set piece which is very costly to produce and not very visual for everyone to see, we will include our flame units to the finale section of the display. These add a real wow factor and always engage the audience. Due to the budget constraints and the proximity of the firing site it is our recommendation that the display will not be able to include 65% to 75% aerial shells. These are also the loudest element of any display, and we
