#### 68/24. COUNCILLORS ON OTHER AUTHORITIES

#### 68/24.1 Cllr N Webb – SADC Devolution

- Cllrs T Lillico and N Webb may be unemployed as part of the SADC Devolution and merge with HCC. SADC will not be going through the first tear of devolution but have applied for tear two.
- Cllr D Yates is going to attend a meeting in the Civic Centre to find out what councils need to do, i.e. look at their assets etc.
- o The process should be finished by April 2028.
- The SADC Local Plan should be adopted by April 2028 when the handover happens.

#### CIIr N Webb - SEGRO

- SEGRO held an exhibition in Park Street, and it was attended by a director of SEGRO who would like to concentrate on Park Street and London Colney.
- They are leaning on contractors and their customers that rent from them to get involved with community funding.
- o There is a meeting this Friday between St Steven's and London Colney Parish Councils to discuss community funding issues.

#### 68/24.2 Cllr T Lillico – Parking

- There is due to be a full professional parking review of central London Colney in the new financial year. This will produce a report to be publicly circulated to the community which will prompt a community meeting. This will get public feedback. Then a public consultation will follow before any changes go ahead.
- o If there are suggestions of charges in Hazeldine car park, this will stop the community using the car park and cause problems in the surrounding streets.
- o Cllr question: Is there a line in the budget for Hazeldine car park?
  - Answer: There is something for London Colney Parking, but nothing specific to Hazeldine car park.

#### 69/24. COMMUNITY SAFETY REPORT

Update of the local shoplifting issues; it has not increased.

Cllrs mentioned the parked lorries on Shenley Lane, by the M25 bridge. There is now an abandoned caravan which is making the situation worse. It was mentioned about children having to walk from Harperbury to go to school in London Colney and they must walk along the pavement where lorries are often parked. Cllr N Webb sent photos to PCSO D Huntley showing the parked lorries. It has also been reported that people have had verbal abuse from lorry drivers if they have gone to take photos of the illegal parking.

It was asked if the PC/PCSO's would do a full report on this situation as it has continued for a long time.

Cllr N Webb has asked for double yellow lines on Shenley Lane to mitigate the lorries parking on the pavement.

#### 1. SUMMARY

The Lunch Club is a long-standing resource for London Colney residents. It has been subsidised for many years by the parish council.

#### 2. **2024/25 OVERVIEW**

Customers currently pay £7.00 for two courses or £8.50 for three courses which includes VAT. It currently costs LCPC £1,725 per month = £20,700 a year

We are charged to produce 25 meals per lunch club. We have sold on average 21.7 meals per lunch club through 2024/25.

#### **Takings for 2024/25:**

Year to date less VAT (week ending 21st February 2025):

£12,964,30

Predicted last 10 lunch clubs at average price of £145.66 per day: £ 1,456.66

Total takings for less VAT 2024/25

£14,420,96

Amount of LCPC subsidy is £6,279.04 for 2024/25

#### 3. **2025/26 OPTIONS**

The HCL prices are going up 3.5% so our total cost will be £21,424.50 to produce 25 meals per lunch club.

The options below are worked out on the average 21.7 meals per lunch club from 2024/25.

The options available are as follows:

- Option 1 We do not increase our prices and increase the subsidy to £7,003.53 for 2025/26
- Option 2 We increase our prices by 3.5% which will give us a predicted income of £14,925.71, making the subsidy £6.498.79.
- Option 3 We increase our prices slightly higher than HCL's 3.5% Two courses at £7.50 (7.14% increase) and three courses at £9.00 (5.88% increase) With the average numbers from 2024/25 this will give an income of £15,527.5, subsidy of £5,897

Option 4 – We could do a best guess increase to what feels like a reasonable price. Increase 2 courses to £8.00 (14.28% increase) and 3 courses to £9.75 (14.70% increase). With the average numbers from 2024/25 this will give an income of £16,847.50, subsidy of £4,577.



Option 5 – We could round the increases up to £8.50 for 2 courses (21.43%) and £10 for 3 courses (17.65%) we would drawing an income of £17,386.76, subsidy of £4,037.74.
