#### 1. APOLOGIES

No Apologies were received.

#### 2. NOTIFICATIONS OF SUBSTITUTES

None.

#### 3. DECLARATION INTEREST

There were no declarations on any item on the agenda.

#### 4. MINUTES OF PREVIOUS MEETING

The minutes of the meeting held on Thursday 24<sup>th</sup> October were received as a true record of the meeting.

#### 5. Working Sub-committees

#### 5.1 Village Day 2025

- This will be a community-based event aiming for 4000 visitors from 12 noon till 4pm on 9<sup>th</sup> August 2025 on Morris Way Playing Field.
- We will invite local groups and businesses within a set radius of the village to participate with interactive/active stalls, including dance groups, scouts, guides, WI, British Legion to mention a few.
- There will be food stalls, local pubs, a main stage and area taking centre stage.
- We are aiming to have competitions, including a cake baking competition, mini dog show and other interactive community shows throughout the afternoon.
- There is the possibility of a fairy hunt for small children.
- A stall to take pre-orders on London Colney merchandise.
- There will be a fold out programme with a map of what activities, groups and businesses are there and a timetable of what is happening on the main stage.
- The majority of the budget will go on the infrastructure.
- The event will be free to the public but profit-making businesses will be asked to contribute for attending i.e. the pubs.

## 5.2 London Colney Pride 2025

- This is a different event from Village Day. It will be held at the Village Green outside the Green Dragon.
- If it is too much to create a second event in the summer months, should we support St Albans and /or Watford Pride instead?
- ACTION to set the next meeting of the working party and change the London Colney Pride 2025 date.

#### 6.1 EVENTS FEEDBACK FROM 2024

Community Officer gave a verbal report with feedback from event since last meeting **Halloween Party** 

- 60 tickets sold sold out
- £80 down on the budget, the bar took less than expected and staffing costs slightly more than budgeted
- £150 sponsorship from Little Nightingales

#### Fireworks

- 3400 sold tickets out of 4100 tickets.
- The Irish Club offered a free event at the same time on the same day.
- We had security for the first time, costing an additional £900, but this put the team at ease knowing the public and they were in safe hands.
- £750 of sponsorship came from MKM.

#### Remembrance Parade

- Another amazing event.
- £1,850 budget but only £1,700 spent.

#### Swing to King

- 100 attended, 85 tickets sold. We gave the volunteers places for free.
- A glass of prosecco was offered to everyone attending.
- £1,000 taken on the bar.
- £820 profit
- Ticket sales should get better closer to the time

#### **Christmas Lights Switch On**

- The lights budget is £13,500, we have signed a contract for 5 years, taking this
  down to £9,760 a year.
- £700 worth of sponsorship.
- £250 on security.

#### **Christmas Biscuits**

- Original £600 budget, but biscuits were donated.
- The community either collected or nominated someone to collect on their behalf. This worked well.

#### **Christmas Lunches**

• 40 people attended for all 3 days; we offered 3 different styles of entertainment per day.

#### **Lunch Club**

- It was discussed if to increase the numbers for lunch club for themed days.
- As the price of food has increased the HCL contact will increase from April 2025 JJo to produce a paper to increase prices from April.

#### **Chantry Island**

- This is such a strong event that is deeply embedded into the London Colney Culture, that maybe we could be advertising this more broadly.
- However, this is a small and intimate event, and it could be in danger of depersonalising the event.

#### **Christmas Lights**

 We would like to switch the lights on a week earlier than 2024, at the end of November 23<sup>rd</sup> December.

#### 8. ANY OTHER BUSINESS

Morris Way Container Cafe – The contractor from the Container Café in Morris Way who ran the refreshments for the Splash Park has resigned as the contractor. We are planning to run this ourselves with Ellen co-ordinating the stock and staff. It opens from the end of May until the beginning of September from 10am until 6pm every day. We are excited to have this opportunity for another inhouse run establishment.

#### Other:

- Stage: I reached out to Marlborough School as requested, they cannot offer hire as it's a fixed stage so can't leave the premises. I have spoken to Leigh (our Grounds Manager) and he said Broadlakes club are looking to purchase a trailer stage, and if that comes in to fruition we may be able to hire at a favourable rate. To date they haven't purchased it, so I have emailed the following companies for a quote for a modular stage: Illumination Events and Alistage. Both coming in around 2-4k depending on size (I asked for quotes on 3 sizes) but will hold on staging and hopefully we will be lucky with Broadlakes, lets give it a month to see before committing to anything else.
- Barriers: I have requested a quote for barriers from Speedy Hire, we're looking around £200 for a like for like on Fireworks, we may not need that many, Leigh and I are doing a site walk tomorrow to discuss.
- Security: I contacted Principle Security for a quote for 4 x security personnel. We have 8
  for our Fireworks event, but given the nature of this event I'm not sure that many are
  required, let's discuss at our next meeting. To have 4 it'll be £500 (inc VAT)
- I emailed Chris Snow to ask if it would be OK to post on the 'London Colney Events and Business Listings' page on Facebook, awaiting reply.

#### 1. SUMMARY

The Lunch Club is a long-standing resource for London Colney residents. It has been subsidised for many years by the parish council.

#### 2. **2024/25 OVERVIEW**

Customers currently pay £7.00 for two courses or £8.50 for three courses which includes VAT.

It currently costs LCPC £1,725 per month = £20,700 a year

We are charged to produce 25 meals per lunch club. We have sold on average 21.7 meals per lunch club through 2024/25.

#### **Takings for 2024/25:**

Year to date less VAT (week ending 21st February 2025):

£12,964.30

Predicted last 10 lunch clubs at average price of £145.66 per day: £ 1,456.66

Total takings for less VAT 2024/25

£14,420.96

Amount of LCPC subsidy is £6.279.04 for 2024/25

#### **2025/26 OPTIONS**

The HCL prices are going up 3.5% so our total cost will be £21,424.50 to produce 25 meals per lunch club.

The options below are worked out on the average 21.7 meals per lunch club from 2024/25.

The options available are as follows:

- Option 1 We do not increase our prices and increase the subsidy to £7,003.53 for 2025/26
- Option 2 We increase our prices by 3.5% which will give us a predicted income of £14,925.71, making the subsidy £6,498.79.
- Option 3 We increase our prices slightly higher than HCL's 3.5%

Two courses at £7.50 (7.14% increase) and three courses at £9.00 (5.88% increase)

With the average numbers from 2024/25 this will give an income of £15,527.5, subsidy of £5,897

**Option 4** – We could do a best guess increase to what feels like a reasonable price. Increase 2 courses to £8.00 (14.28% increase) and 3 courses to £9.75 (14.70% increase). With the average numbers from 2024/25 this will give an income of £16,847.50, subsidy of £4,577.



• Option 5 – We could round the increases up to £8.50 for 2 courses (21.43%) and £10 for 3 courses (17.65%) we would drawing an income of £17,386.76, subsidy of £4,037.74.
